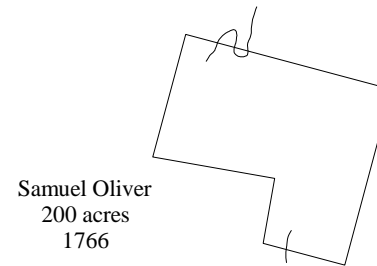


Latta, Gill, Wylie, Hicklin, Gaston Place

Latta, Gill, Wylie, Hicklin, Gaston Property

- **1766** -Land Grant to Samuel Oliver – 200 acres - **SC Archives**
- **1767** -Conveyed by Samuel & Elizabeth Oliver to John Latta Sr. – 132 acres – Deed Not Recorded – (Information taken from Later Deeds)
- Willed to John Latta Jr. Not Recorded
- **1833**- John Latta Jr. to James Gill – **Chester Co. Deeds Bk Z-Page 194** 130 acres
- **1846** – Elizabeth Gill to Lewis Harrison Gill- **Chester Co. Deeds Bk. FF p. 93** 144 acres. Elizabeth Gill was wife of Thomas Porter Gill (Tanner) 1796- 1845. See attached rendering of Metes and Bounds. Land said to be purchased from Lewis Gill and wife Mary. (Not Recorded)
- **1849** – Lewis H. Gill to Peter Wylie – Chester Co. Deeds Book II p.625 132 acres Reference to plat made by David Daniel – 1816. Metes and Bounds given in deed.
- **1854** – Peter Wylie to Dekalb Wylie – Deed of Trust for William Wylie, wife and children. Land on which William Wylie now resides. See attached Deed of Trust. **Chester Co. Deeds Bk.II p. 190** – 132 acres. Metes and Bounds by reference to the earlier Deeds.
- **1868** – William Wylie Died. His heirs were all minor children. John Edward, Amanda, William, Mary. Trust continued.
- **1912** – Will of Jason C. Hicklin – leaves to wife Sallie Strait Hicklin and my two daughters, Isabella and Sarah the remainder of my land where we now live containg 154 acres. Each to have an equal interest. Frank Hicklin and WW. Gaston executors. See attached plat dated 1894.
- **1924** – Will of Sarah J. Hicklin- gives to Sue Hicklin Gaston all right and title (being ½ interest) in 150 acres of land which I with my sister Belle inherited from my parents known as the J.C. Hicklin home.
- **1930** – Sallie Hicklin to Mary Isabella Hicklin and Sarah J. Hicklin
- All right and title to interest in JC Hicklin homeplace. **Chester Co. Deedbook 276 Page 371**
- **1934**- Codicil to Will of Sarah J. Hicklin- received from sister Belle Hicklin, disceased, one third interest in her half interest of the JC Hicklin homeplace. Dispose of my one third and use the proceeds to erect a suitable memorial to the graves of my parents, my sister Belle, and myself.
